# **Emissions reduction targets**

To achieve Net Zero, and in line with the Science Based Targets initiative SBTI, we have adopted the following carbon reduction targets:

We are committing to reduce our Scope 1& 2 emissions by at least 45% by 2030 and 90% by 2040.


We are committing to reduce our Scope 3 emissions by at least 30% by 2030 and 90% by 2045.

## **Carbon Reduction Projects**


We are committed to monitoring our carbon emissions and conducting annual carbon footprint calculations covering all three scopes. This commitment will be effective throughout the duration of the contract.

- 1. Electrify our boilers by 2032.
- 2. Electrify our company fleet by 2032.
- 3. Move to renewable energy or switch to a green contract by 2040.
- 4. Use recycled materials and transition to low-carbon services to achieve at least a 5% annual reduction in emissions in this category.
- 5. Implement an alternative transport program to reduce air freight emissions by 5% annually.
- 6. Reduce our waste emissions by 5% annually.
- 7. Offer eco-commuting options, such as EV salary sacrifice schemes and cycle-to-work programs.
- 8. Adopt alternative downstream transportation methods to reduce emissions by 5% annually.
- 9. Reduce emissions from the end-of-life phase of our products by working with our clients to improve the recyclability of materials, aiming to achieve a 5% reduction in end-of-life emissions.

These steps will collectively help us reduce our emissions by 92%.

# **Declaration and Sign Off**
